Dear Members of the Addison Central School District Community:

"Committed to Student Success." This statement, along with the District Strategic Plan (included on the following page) inspire and guide the work of our faculty, staff and administration each and every day. In partnership with our families and community, we strive to "provide students with a safe, engaging and challenging learning environment in order that they are prepared for success in a global society." We are deeply appreciative for these partnerships and continued support they provide toward the achievement of our mission, vision and goals, as they cannot be accomplished in absence of this collaboration.

Equally essential to the success of our schools and, ultimately, our students, is a strong and balanced financial foundation. District finances must carefully balance the fiscal realities of the community and its residents with the ever-rising costs of operating a school district comprised of more than 1,000 students, more than 230 employees and three school buildings in the effort to provide the best educational experience for all students. This requires thoughtful, yet agile, long-range planning and the utilization of resources in the most efficient and effective means possible. This, too, guides our decision making as we work toward fulfilling our commitment to student success.

Again this year, the proposed budget continues an unprecedented decrease in tax rate over the past *eleven* consecutive years, a decreasing tax rate per \$1,000 of assessed valuation by 35% in this time period. In the last year alone, the tax rate decreased by more than 12%. This is despite the fact that the district will receive 2.4% less Foundation Aid than initially anticipated. Foundation Aid represents more than 45% of the school district's total revenue. This makes a 1% increase on the tax levy proposed for the 2024-25 school year budget even more critically necessary in order for the District to continue to provide the rigorous academic courses, as well as the engaging programs and opportunities that our students deserve and our community expects (see pages 3-5 of this document for featured programmatic highlights).

The budget proposed for the 2024-25 school year has been developed in careful consideration of the economic realities of the school community, the costs of operations and providing the best opportunities possible for our students, as well as the fiscal conditions in which this must occur. The proposed budget serves to ensure that we can keep students as the primary focus and, not only maintain stability in, but continuously work to improve, the educational experiences of our students through tumultuous economic times, thus coming closer to the realization of the District's mission. The success of our students remains our commitment and fulfilling this commitment serves to strengthen our community. Once again, we greatly appreciate the partnerships and support of our families and community members. Please carefully review and consider the information provided in this newsletter and the budget proposal, contact the District Office regarding any questions and make your voice heard by voting on May 21, 2024, at the Addison High School Library.

## **GOAL #4** - Non-Instructional Support Initiatives:



#### **GOAL #5** - Supporting District Faculty & Staff:


By June 2028, the District will improve its effectiveness and efficiency in the area of human resources and staff relations by instituting improved human resources processes and procedures for all new and current staff.

# Middle School




(Right) All Middle School students take a Life Skills class, where they practice food preparation and cooking skills, along with first aid and safety.



(Above) Students brainstorm, build and write code for robots that they build using their own creative designs. Students learn from and correct their errors in order to get the desired end product.




(Above) Middle school students dissect owl pellets to learn about the eating habits of birds of prey.





# Three-part budget breakdown

Program \$25,127,958 69.5%


The Program Component includes all instructional program expenditures, including the salaries and benefits of teachers and any school administrators or supervisors who spend a majority of their time performing teaching duties, and most transportation operating expenses. This total includes regular instruction, education of those with special needs, occupational education, curriculum, staff development and summer school, as well as pupil services such as health, guidance, library, co-curricular, athletics and transportation.

<u>Capital</u> \$7,098,249 19.6%

The Capital Component includes all capital, debt service, lease expenditures, and some transportation; costs resulting from court judgments, administrative orders, settled or compromised claims; and all facilities costs of the District, including facility lease expenditures, annual debt service and total debt for all facilities financed by bonds and notes of the District, and costs of construction, acquisition, reconstruction, rehabilitation or improvement of school buildings, and all expenditures associated with custodial salaries and benefits, service contracts, supplies, utilities and maintenance repair of school facilities, including plumbing, electrical and general construction.



The Administrative Component includes office and central administrative expenses, travel expenses, salaries and benefits of all certificated school administrators and supervisors who spend a majority of their time performing administrative or supervisory duties, all expenditures associated with the operation of the school board, the superintendent, general administration, the school business office, any consulting costs not directly related to student services and program planning, and all other administrative activities.



## Am I eligible to vote?


To be eligible to vote on the school budget and election, you must be a citizen of the United States who is 18 years of age or older and a legal resident of the Addison Central School District for at least 30 days prior to the vote. No prior registration is required.

## How can I get an absentee ballot?

To receive an absentee ballot by mail, you must pick up and return an application at least seven business days prior to the vote. If you are picking up an application and ballot in person, you may do so up to one day prior to the vote. Applications and ballots are available at the District

Office from 7:00 a.m. to 3:30 p.m., Monday through Friday.

Absentee ballots will be counted only if they are returned no later than 5:00 p.m. on May 21. Call Board Clerk Kristie Mather at (607) 359-2244, ext. 1 for more information.
