Currently the program serves 120 kids per day 3 locations. In 2010 there were 250 outh between the 3 sites, and over 264 weekend bags and 1,000 evening snacks

were provided to the youth over the summer. The Center currently provides homework assistance and fun structured programs on all school days and the summer months.
