Ms. Crane then introduced students Zach Knapp, Lexis Pallmann, Ben Hamilton Calin Nichols and Corrine Crooker as the Everyday Hero awards. These students are nominated by faculty members based on their community involvement, leadership, motivation and kind gestures. They also received recognition certificates.

The Superintendent reviewed the following correspondence: Information from the State Education Department noting that 95.2 % of school districts budgets passed, which is down from last year which was 96.5 percent. Although districts have received state aid increases the last two years, 70 percent of the districts are still receiving less aid than in 2008-2009. Another interesting note gathered from the state annual Census Bureau report on school district finances for the school year ending in 2011, is again New York leads the nation in per pupil spending and there are a couple factors Contributing this, i.e. New York is a high cost of living state and not just in education; we offer more services, and parents want their children to get extra help from these services and parents supply most of votes for the budgets; no other state has a Wicks Law requiring the use of multiple prime contractors on construction project; no other state has a Triborough Law or guarantees annual step increases after a contract expires. Another reason is that roughly three-quarters of school spending goes into personnel.

Mr. DioGuardi also stated that this year we conducted an exit poll survey after the voters had voted and felt that there was a lot of positive feedback as well as a few negative comments. As soon as possible a complete summary of surveys will be done.

No one wished to be recognized during the public forum.

At this time, the Superintendent introduced the representatives from Campus Construction and then they did a presentation showing the preliminary design estimate for the Phase II project. In reviewing the information, the Board asked questions relative to the scope of the work and where. Mark Voorhees from Campus stated that at this point with changes that have needed to be done, etc. the project is about \$1.4 million over projections and with that information, some priorities will have to be set. The Board stated that the bathrooms at Tuscarora, the pool problems at the high school, the asbestos and the flooring at Tuscarora and the basketball court at each building were of importance to them and the seating capacity for the new gym could be reduced from 800 to 600, the same as we have at the high school. Mr. Voorhees stated that the committee would be meeting again (every other Wednesday) and discussion regarding all this would take place.
